1. Wealth of State in Privatization of Soe

The 2003 act of no. 17 defines state finances as all the rights and obligations of the state that can be assessed with money, and all things of either money or property can be made state in accordance with the administration of that right and obligation. "Anyone who aims to benefit himself or another person ora corporation, misusing authority, opportunity or means on its part because of an office or position that would adversely affect national or economic finances."

Not all of the actions of directors who commit administrative errors that are detrimental to the state's finances are inducted into corruption, when decisions are made with prudence, good intentions and not to benefit themselves are the foundation of the board. But when it meets state losses, article 20 of the 2014 rule number 30 on government administration, government officials who commit administrative errors incur state losses, are required to recover such losses when administrative errors result from misappropriation of authority. May also be charged with administrative duty and criminal sanctions as set up in article 64 of the no.1 of 2004 law on state Treasury.
